#### 1. Challenge

- ✓ Google "Apples as a Garnish" or "Vegetable Animals" or "Fruit Carving" or something similar. If you start with apples, you may branch out into many different fruits and vegetables as you search.
- ✓ View a few of videos and decide on your project. You can follow the instructions you find online or make up your own creation.
- ✓ Create your "Fruit or Vegetable Art" project.
- ✓ Take 4 photographs of the process.
- ✓ Write a short reflection on the process that outlines (minimum 100 words)
  - Your source of inspiration (URL link provided)
  - O What went well in the process of creating the art?
  - What were some of the challenges in creating the art?
  - What would you change for next time if you did this project again?
  - O What did others say about your product?

## 2. Categories

- ✓ Two categories:
  - o Kindergarten Grade 7
  - Grades 8 12
- ✓ The winner of each category will receive a \$50 e-gift card.
